

Richard Berger (Lehrer)

Richard Berger (* 3. August 1900 in Leipzig; † 30. Juni 1948 im Speziallager Nr. 1 Mühlberg) war ein deutscher Lehrer und Heimatforscher für das Erzgebirgsdorf Breitenbrunn.

Leben

Berger studierte am Königlichen Lehrerseminar in Borna bei Leipzig. Nach erfolgreichem Studium wurde er 1924 als Lehrer an der Volksschule Breitenbrunn eingesetzt. Berger war von 1925-1933 erster Vorsitzender des Erzgebirgszweigvereins Breitenbrunn. 1921 gründete er die Sparte Ski im Arbeiter-Turn- und Sportbund "Vorwärts" Breitenbrunn.^[1] Von 1925-1939 leitete er die Abteilung Ski innerhalb des 1923 gegründeten bürgerlichen Deutschen Turnvereins Breitenbrunn, der 1934 im Deutschen Reichsbund für Leibesübungen aufging. 1933 wurde Berger zum Gauschneelaufwart (eine leitende Position im Skiverband) ernannt.^[2]

Berger verfasste heimatgeschichtliche Beiträge über Breitenbrunn und Umgebung. In seinen Forschungen arbeitete er mit Hans Siegert, Siegfried Sieber und Walter Fröbe zusammen. Seine Beiträge zur Lokalgeschichte wurden auch nach seinem Tode in der Fachpresse rezipiert.^{[3][4][5]} Bergers Geschichte der ehemaligen Papiermühle Breitenbrunn wurde 2003 in die *Internationale Bibliographie zur Papiergeschichte* des Deutschen Buch- und Schriftmuseums in Leipzig aufgenommen.^[6]

Im Zweiten Weltkrieg schrieb Richard Berger Heimatbriefe an Wehrmachtssoldaten an der Front. Nach dem Krieg wurde er ohne Angabe eines Grundes am 12. September 1945 verhaftet und vom Schloss Schwarzenberg aus ins Speziallager Nr. 4 Bautzen und von dort am 9. Oktober 1945 ins Speziallager Nr. 1 Mühlberg gebracht. Nach dreijähriger Lagerhaft verstarb Richard Berger am 30. Juni 1948 im Alter von 47 Jahren an Lungen-Tbc. 1995 wurde er von der Militärhauptstaatsanwaltschaft Moskau als tot und als unschuldig inhaftiert erklärt.

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. If you have Invariant Sections, Front-Cover Texts and Back-Cover Texts, replace the "with...Texts." line with this:

with the Invariant Sections being LIST THEIR TITLES, with the

Front-Cover Texts being LIST, and with the Back-Cover Texts being LIST.

If you have Invariant Sections without Cover Texts, or some other combination of the three, merge those two alternatives to suit the situation.
